CITY COUNCIL ACTIONS - Action taken by the City Council on November 9, 2015 included final acceptance of Part 2 of the Washington Avenue Link Project; acceptance of a donation for installation of an irrigation system on Field #3 at Jefferson Park; approval of the final plat of Magner Farm Second Subdivision; acceptance of the November 3, 2015 general election results; approval for modification of the position description for Production Assistant; approval for the Hospital to modify a former nursery space into an on-call room; approval to call for a public hearing for the City to act as a conduit bond issuer for Vista View LLC; and vacation of interior easements between two lots at Windsor Pond subdivision. The Council also met in closed session with the City Attorney to discussed threatened litigation.

The next City Council meeting is November 23rd at 7:00 p.m. in the Governors' Room of the Community Center. HOLIDAY CLOSURES – All nonemergency City offices, including the Library, will be closed on Thursday, November 26th and Friday, November 27th for Thanksgiving.

There will be no transit service on Thanksgiving Day, but normal hours will resume on Friday.

The Community Center will be closed on Thanksgiving Day, but will be open regular hours on Friday.

The Library will reopen for Saturday hours.

SNOW PREPARATIONS – It's not too early to be planning for heavy snowfalls this winter, and residents who would like to be notified of snow emergency declarations should sign up now for the Nixle community notification system if you haven't already done so. It's a free service and easy to do.



Go to www.nixle.com and follow the prompts to create an account for City notices. You can choose whether you wish to have notices sent by e-mail, by text, or both!

If you don't have an off-street parking space available to you, make arrangements now to find a spot to park your vehicle before snow emergency declarations are in place.

Property owners with sidewalks are also reminded of the City regulations that require sidewalks, including handicap ramps at intersections, to be cleared of all snow and ice within 24 hours after a snowfall. The walkway must be cleared the entire width and be kept clear of blowback and drifting snow. Property owners who don't clear their walks may face hefty fees from the City when City crews are dispatched to do the job. Minimum charge? \$75!

And for all those who plow snow for a living, please remember that it is illegal to plow the snow out into the street or onto the City owned boulevard. This creates a danger for the public and sight line issues for other drivers.

So get started on your winter preparations now and don't wait for the first snowflakes to make plans!
